Speaker Biographies



Nick Brown - Commercial Recycling Manager, Coca-Cola Enterprises

Nick Brown is Commercial Recycling Manager for Coca-Cola Enterprises (CCE). The role was created as part of CCE's investment in CSR, with the ultimate objective of meeting the business's commitments on recycling. Nick is building new ways of changing consumer behaviour, improving collection systems and supporting recycling industries in GB through a series of partnerships that will ensure CCE is a leader in this field. The most recent of these is the Joint Venture agreement between CCE and ECO Plastics to more than double the amount of food grade PET material produced in GB. Nick's background is in Operations Strategy and New Product Development.



Nick Cliffe - Marketing Manager, Closed Loop Recycling

Nick Cliffe is an innovative UK recycling company – specializing in the recycling of plastics and the design and delivery of closed loop recycling programmes for food & beverage packaging. Previously Nick worked for Green-Works, a Queens Award winning social enterprise that recycled contract office furniture and the Forest Stewardship Council (UK), a world-wide sustainable timber certification system. Nick is a specialist in packaging recyclability and building communication programmes around the concept and practice of delivering closed loop recycling solutions.



Mark Ellis - Manager Materials Design & Test, Nissan Technical Centre Europe

After completion of a degree in mechanical engineering design Mark then completed a master's degree in automotive engineering, before joining Nissan's European Technical Centre in 1991, initially assigned to the engine design department Mark then transferred to the materials design department, where he has been involved in the design and development of many polymeric material applications on Nissan's European product range. Following formation of the Nissan-Renault alliance, Mark has been working on material synergies and European / Global polymer strategy, most recently on polymeric materials for reducing vehicle weight. After a secondment to Nissan's main technical centre Mark was promoted to the position of manager within the materials department.



Jane Gardner - Axion Consulting

Jane Gardner is a Senior Consultant for Axion Consulting, who are the UK agents for Recovynyl. Jane has worked for Axion as part of the UK Recovynyl team since 2005 and manages the recycling and collection services team at Axion. Jane has worked on a range of projects in the construction and demolition sector specialising in setting up collection schemes such as the vinyl flooring take back scheme Recofloor.



Duncan Oakes - Commercial Director

Duncan has worked within the recycling industry for over 10 years. Originally involved in sales of capital equipment such as balers and shredders with Riverside Waste Machinery Ltd. In 2004 Duncan joined ECO Plastics as a buyer covering northern England. As the company has expanded Duncan has grown with it and now oversees all commercial aspects for the company.



Paul Davidson - Special Advisor WRAP

Having graduated in Materials Science and Technology, Paul studied the processing of PET bottles for a higher degree at Loughborough University of Technology. He spent the next 3 years developing flame retardant compounds at Albright and Wilson before joining Uniroyal Chemical (now Chemtura) in 1996 as European Technical Product Manager. Paul then joined WRAP (Waste and Resources Action Programme) in July of 2001 and is now their Special Advisor for plastics matters. During this time Paul has led WRAP's work in developing plastics recycling technology and infrastructure in the UK.
